

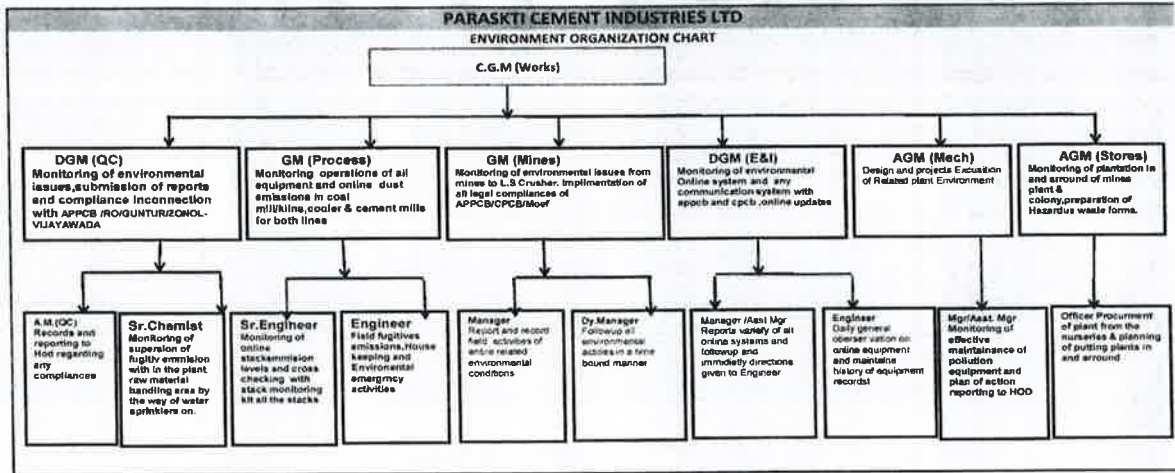

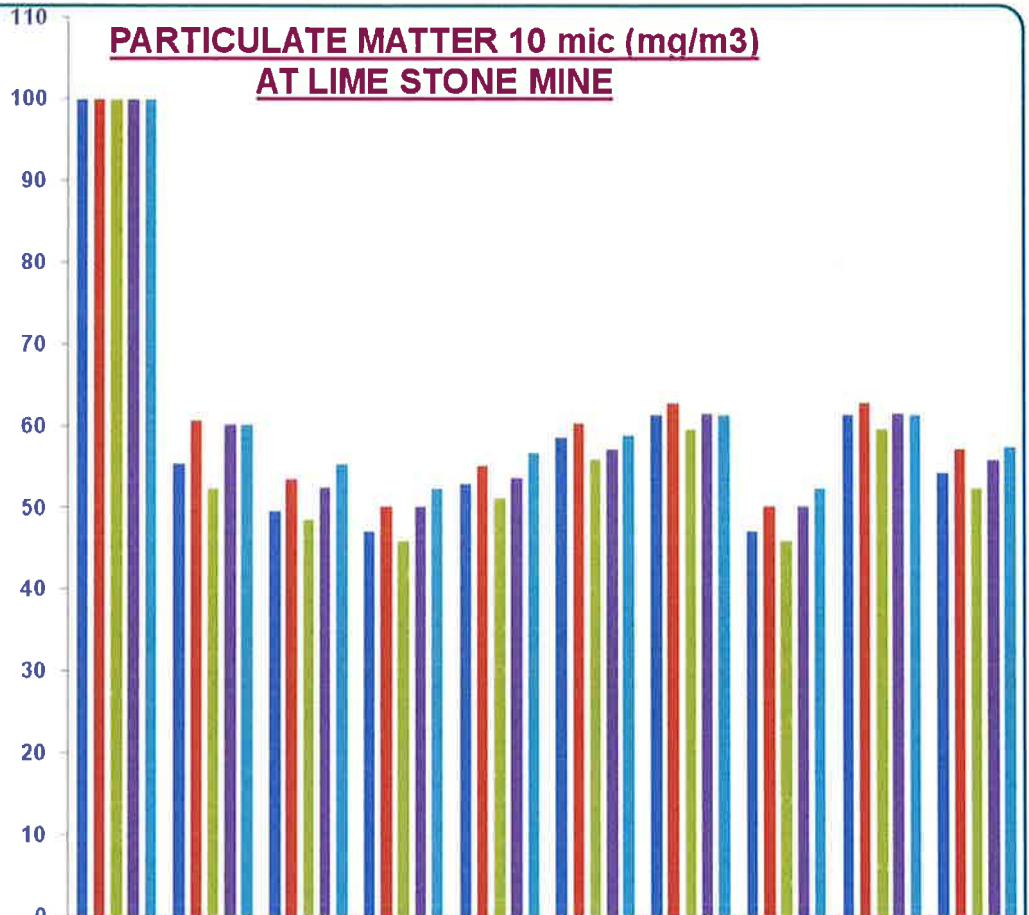

AT LIME STONE MINE

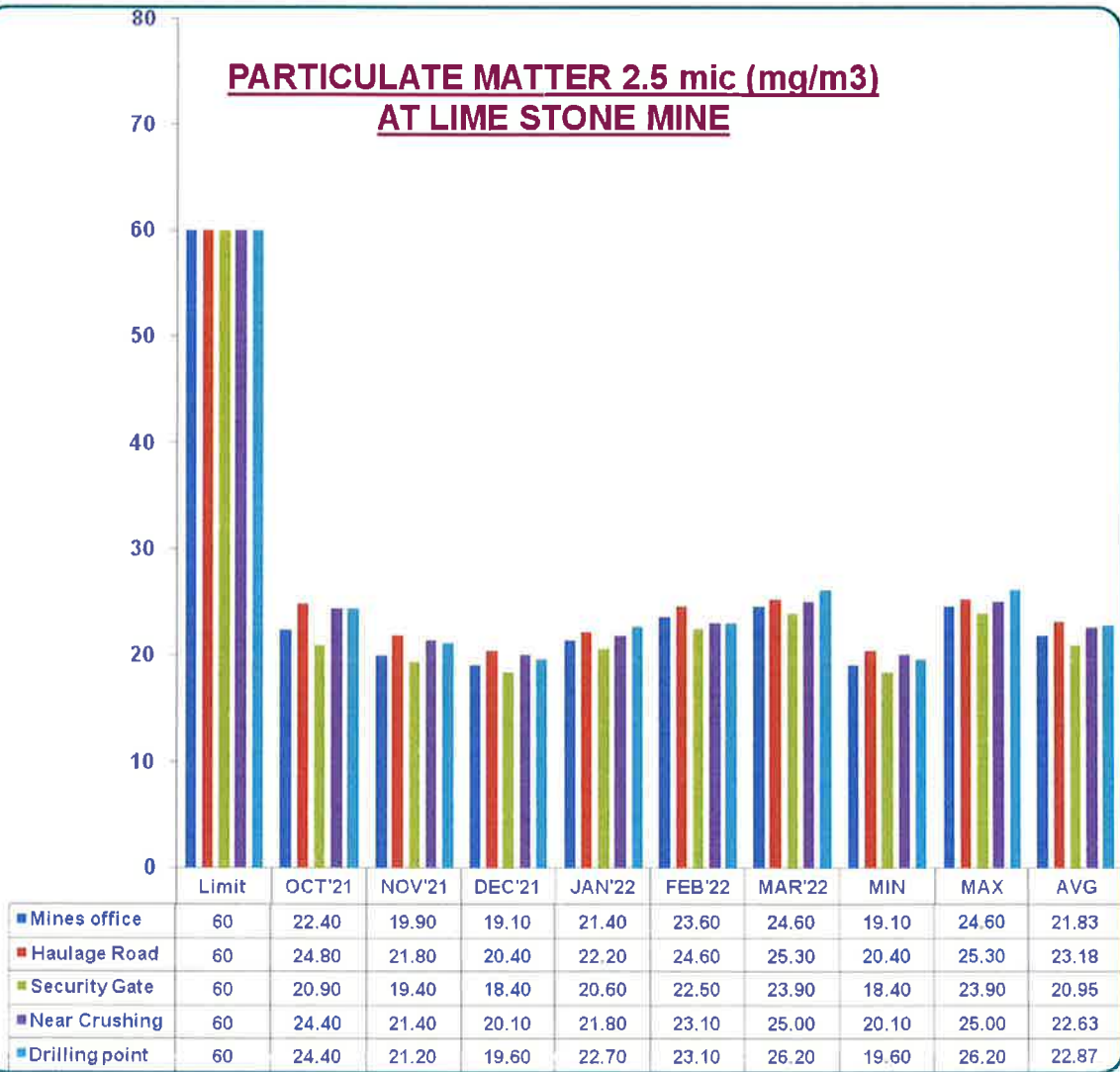

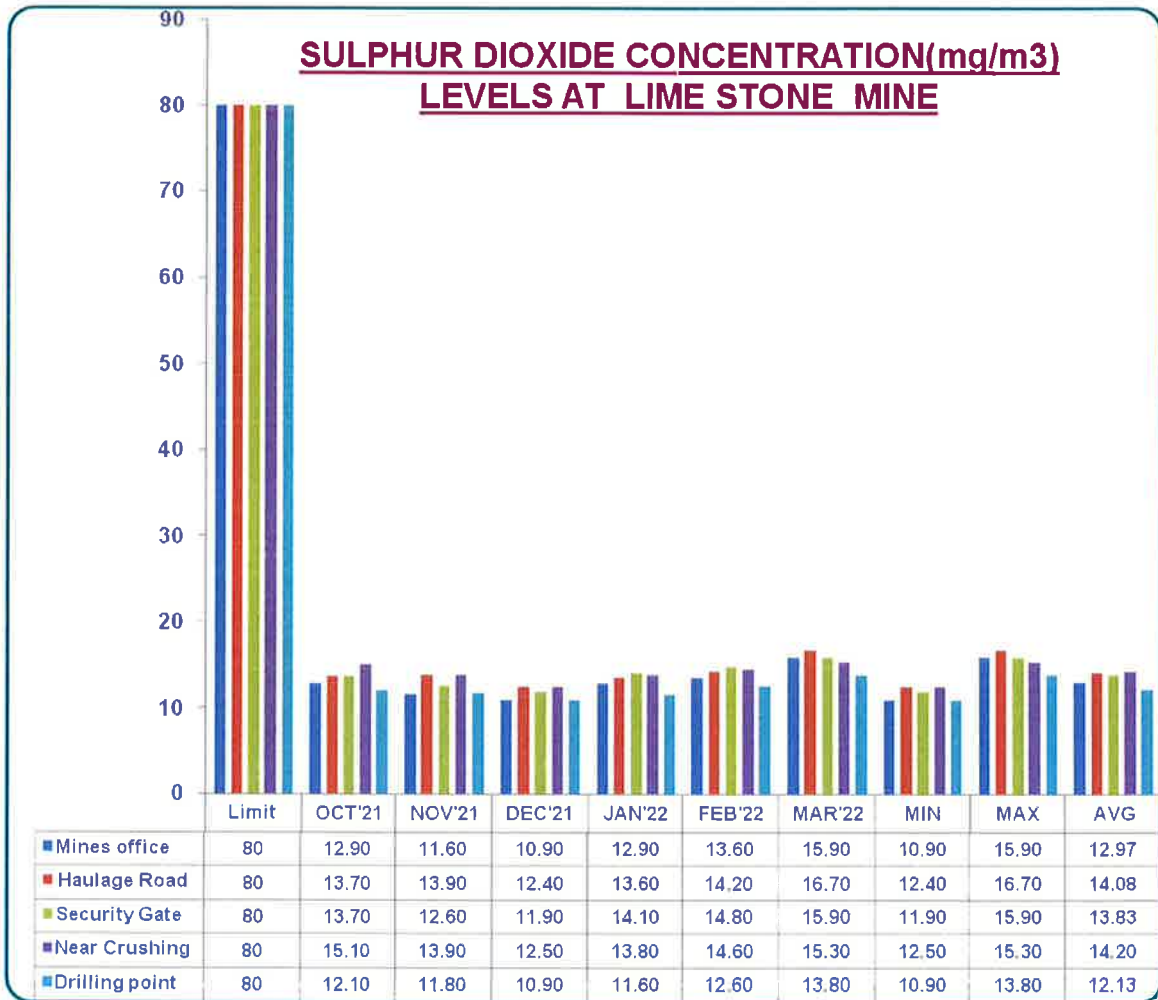


PARTICULATE MATTER 2.5 mic (mg/m3)
AT LIME STONE MINE



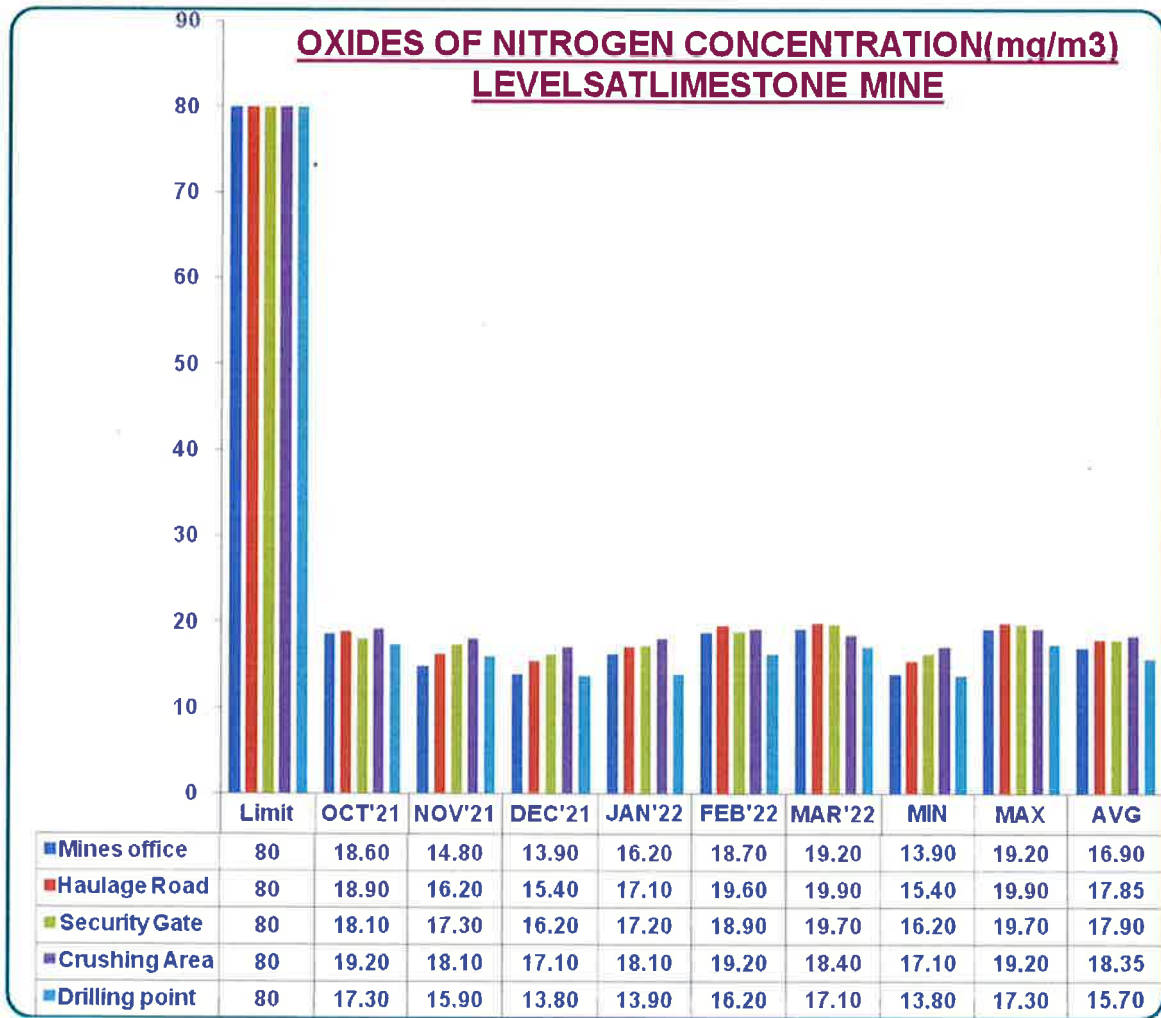

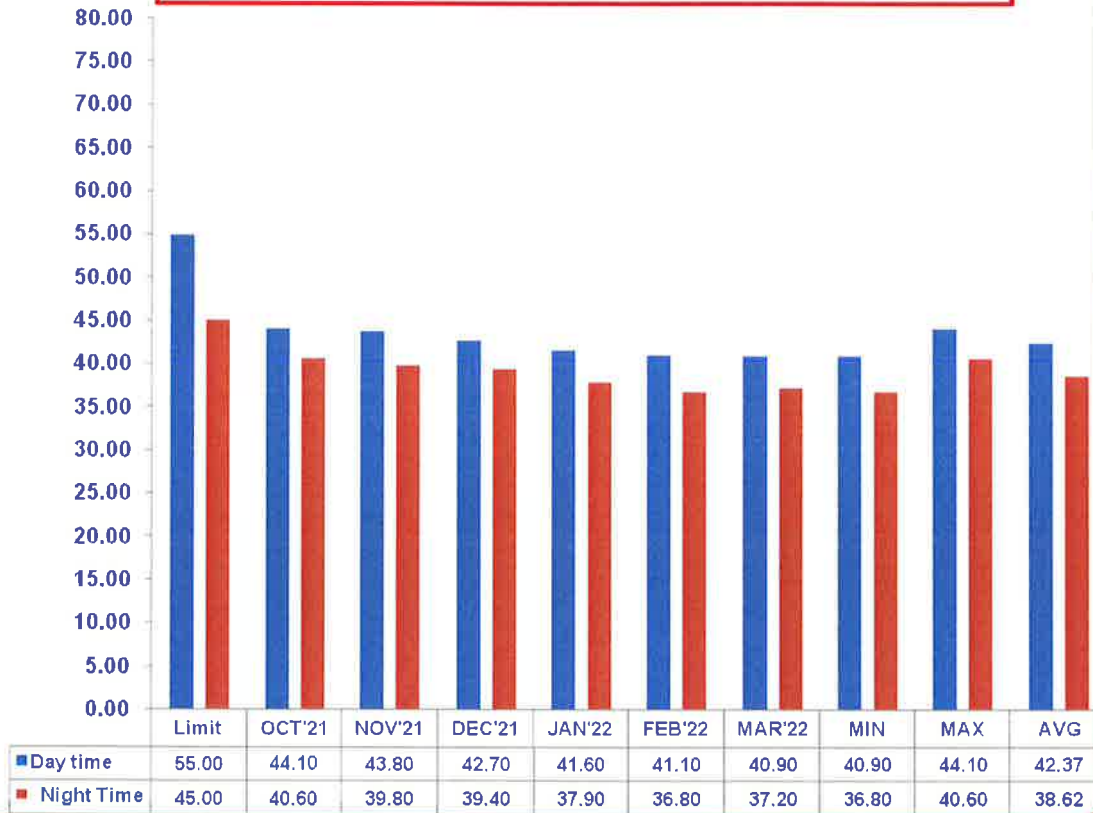
NOISE LEVELS AT JATTIPALEM (V) (dB) AT LIME STONE MINE

VIJAYAWADA: TDP official spokesperson Namapaneni Rajakumari on Tuesday took strong objection to the Government's reactions in the aftermath of startling allegations made by the former Vigilance Commissioner, R.C. Samal.
 Addressing a press conference here, Ms. Rajakumari said instead of taking any concrete action to root out corruption, Chief Minister Y.S. Rajasekhara Reddy sought to defend the "black sheep in his Cabinet." On the other hand, Dr. Reddy was levelling baseless allegations against TDP president N. Chandrababu Naidu.
 Ms. Rajakumari termed as totally unwarranted the Chief Minister's statement that controversies surrounding Mr. Samal now and evangelist K.A. Paul in the past were creations of Mr. Chandrababu Naidu.
